Form C - for Claims by financial creditors (See Regulation 8)

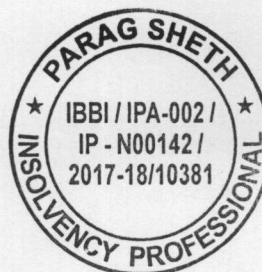
Form D - for Claims by workmen and employees (See Regulation 9)
